

# SPORT SA MEMBERSHIPS

## CATEGORIES & ELIGIBILITY

### FULL MEMBERSHIP

Voting rights. Shall be made available to:

- All State and Peak Sporting Organisations as recognised by the Office for Sport, Recreation and Racing.
- Significant umbrella organisations or sporting or allied industry bodies that are not recognised as a State or Peak Sporting Organisation by the Office for Sport, Recreation and Racing.

### ASSOCIATE A MEMBERSHIP

Voting rights. Shall be made available to significant sporting industry organisations which are not recognised as the state body.

Small - 0-4 FT staff or equivalent  
Medium - 5-9 FT staff or equivalent  
Large - 10+ FT staff or equivalent

### ASSOCIATE B MEMBERSHIP

No voting rights. Shall be made available to sporting clubs, sporting entities, commercial organisations involved in/associated with sport or the sporting industry, schools, and local government associations.

Club Membership - 150+ Members  
Small Club Membership - <150 Members

### INDIVIDUAL MEMBERSHIP

No voting rights. Shall be made available to persons involved in sport or having a keen interest in the sporting industry.

### CORPORATE PARTNER MEMBERSHIP

No voting rights. Shall be made available to commercial entities whose core business is not primarily sport. Corporate membership shall be a tiered membership base.

### LIFE MEMBERSHIP

No voting rights. Shall be awarded to individuals who have made significant and outstanding contributions to Sport SA and the sporting industry.

# FEES

## ANNUAL MEMBERSHIP FEES

All members, except for life members, shall pay an annual membership fee. Membership fees for the following year shall be determined by the Board of Directors and announced at the Annual General Meeting, failing which the current year's fees shall stand. Membership fees shall be payable within sixty (60) days of the beginning of the financial year. The financial year of the Federation shall commence on 1 July.

## PRO RATA FEES FOR NEW MEMBERS

All new members, irrespective of category, who join part way through a financial year, shall pay the annual membership fee as determined under the previous clause, on a pro rata basis for the remainder of that financial year. The pro rata calculation shall be:
